The hearing is regarding the issuance of obligations by the Issuer, which may be issued pursuant to a plan of finance in one or more series, in an aggregate principal amount not to exceed \$35,000,000 (the "Bonds"). The Bonds will be issued as exempt facility bonds for a qualified residential rental project pursuant to section 142(a)(7) of the Internal Revenue Code of 1986, as amended (the "Code"). Proceeds of the Bonds will be loaned to LDG Walnut Springs, LP, or an affiliate thereof (collectively, the "Borrower") to partially finance an affordable multifamily housing development (the "Development") located at approximately 2450 North Guadalupe Street, Seguin, Guadalupe County, Texas 78155. The Borrower is the initial owner and principal user of the Development.
